As per orders read as second paper above, 60 (Sixty) senior-most Head Clerks in this department were promoted as Junior Superintendents. Smt. Fathima. P.M, Head Clerk, who is ranked as serial No. 87 in the seniority list of Head Clerks published vide proceedings 1st read above, was not considered then for promotion as Junior Superintendent, for want of declaration of his probation in the cadre of Head Clerk.

Now, orders have been issued, vide proceedings read as third above, declaring his probation in the cadre of Head Clerk with effect from the FN of 09.09.2016 FN.

Accordingly, orders are hereby issued promoting Smt. Fathima. P.M, Head Clerk to the cadre of Junior Superintendent provisionally as per KS & SSR in the scale of pay of Rs. 30700-65400/- and posting her at the O/o the Executive Engineer, Quality Control Division, Thrissur in the existing vacancy. She will be on probation for a period of one year from the date of joining duty as Junior Superintendent within a continuous period of two years in service. The promotion of Smt. Fathima. P.M is with effect from 23.07.2019 as his immediately junior Smt. Soorya Prabhakaran, Head Clerk (ranked '89' in the provisional seniority list first read above) was promoted to the cadre of Junior Superintendent vide the proceedings second read above.

The above order of promotion is purely provisional and shall be subject to review based on the decision to be taken by the department on the report of Anomaly Cell.

Smt. Fathima. P.M, Head Clerk shall join duty as Junior Superintendent in the new station forthwith. The Controlling Officers concerned shall download copies of the order from the official website of the department and issue necessary relieving / posting orders to the incumbent under intimation to this office.
