I am to inform you that Central Ground Water Board has launched a mobile app "Jal Sanchayan" which is a user-friendly Android Mobile Application comprising all components of rainwater harvesting in single platform. It can be downloaded in to any Android Mobile phone from "Google Play Store" (Free of cost). The application has build in bilingual (Hindi and English). It also provides location based ground water levels (from the nearest

Hydrograph monitoring station of CGWB), annual average rainfall and Aquifer information. It enable user to calculate potential rainwater to be harvested and suggest user on feasible rain water harvesting structures and approximate cost to build. A copy of the "Jal Sanchayan" Mobile Application information is enclosed. This information can also be downloaded from the website of Central Ground Water Board & Ministry of Water Resources, River Development & Ganga Rejuvenation.
