ORDER

The Chief Engineer (I&A) as per letter read as 1st paper above has submitted a proposal for the "Rehabilitation of Lift Irrigation Schemes" and has requested to accord Administrative Sanction for an estimated amount of ₹7.512 Crore under the Head of Account '4702-00-101-73 (P) Rehabilitation of Ll Scheme'.

- 2) The Special Working Group meeting held on 06/11/2014 considered and approved the proposal for "Rehabilitation of Lift Irrigation Schemes" with a total outlay of ₹7.51 crore subject to some general conditions.
- 3) In the above circumstances Government are pleased to accord Administrative Sanction for the "Rehabilitation of Lift Irrigation Schemes" for an outlay of ₹7.51 Crore (Rupees Seven Crore and Fifty One lakh only) under the Head of Account '4702-00-101-73 (P) Rehabilitation of LI Scheme' subject to the following conditions:
 - The fund release will be based on actual requirements and the fund released should not be parked in Banks.
 - Store Purchase Rules shall be strictly adhered to

- Tender / e-tender and other stipulated formalities shall be followed wherever necessary.
- For Civil works CPWD rates shall be followed.

The Chief Engineer (I&A) will monitor the implementation of the scheme and will report to government quarterly.
